"Will You Do Me a Favor?"

It's generally not my norm to ask for favors. But this one won't cost you anything and you don't have to do it today (more about that later). We are now just 26 days away from Election Day. Here are a few things to re-emphasize has we approach November 5th.

- 1. There are 14 physical locations in Henry County. The polls will be open from 7:00AM until 7:00PM at each location. If you are a registered voter in Henry County, you have been assigned to vote at one of those locations. If you have questions about your voting location, please contact the Henry County Registrar's office at (334) 585-6080.
- 2. If you are not a registered voter, the deadline to register to vote is Monday, October 21st. You can register at the Registrar's office on the 2nd floor of the Henry County Courthouse.
- 3. If you wish to vote absentee, you have most of October to apply for an absentee ballot. To get the official deadlines and requirements, contact the Henry County Circuit Clerk's office at (334) 585-2753.
- 4. There have been many questions about the ability to 'split' your vote between parties. Yes, you CAN do this in a General Election. Email me if you have any questions about this: davidmoney3737@gmail.com.
- 5. You MUST have a state issued photo I.D. before you will be allowed to vote.
- 6. The taking of photos or videos inside the voting precinct will be prohibited.
- 7. We are anticipating (and hopeful) that there will be a large voter turnout. It has been my experience that lines are longest between 7:00 and 8:00 in the morning when the precincts first open and then again between 3:00 and 6:00 PM when school ends and when citizens are getting off work.

The subject of voter turnout leads me to the request for a favor. In the past few elections, Henry County has led the Wiregrass in the percentage of registered voters who actually voted. In the Spring Primary Elections, the average turnout throughout the Wiregrass was around 20%. If memory serves, Henry County was between 25% and 28%. My goal for the General Election is that a minimum of 65% of registered Henry County voters exercise their right to vote on November 5th. When I look at the state of affairs in our country today and ponder what lies ahead for our children and grandchildren, it is my personal opinion is that this may be the most important election of our lifetime. The favor is simply this: PLEASE VOTE!
